

सुप्रीम कोर्ट में चुनाव सुधार की

युवक कांग्रेस करेगी पीएम कार्यालय पर प्रदर्शन

नई दिल्ली, वार्ता। युवक कांग्रेस राफेल विमान सौदे में कथित गड़बड़ी को लेकर मोदी सरकार के खिलाफ प्रधानमंत्री कार्यालय के बाहर प्रदर्शन करेगी।

युवक कांग्रेस के अध्यक्ष अमरिंदर सिंह राजा ने यहां बताया कि 16 फरवरी को सरकार तथा प्रधानमंत्री नरेंद्र मोदी के विरोध में प्रधानमंत्री कार्यालय के बाहर प्रदर्शन किया जाएगा। उन्होंने कहा कि वह खुद इस प्रदर्शन का नेतृत्व करेंगे। यह प्रदर्शन संगठन के पांच रायसिना रोड स्थित कार्यालय से आरंभ होगा जहां से कार्यकर्ता प्रधानमंत्री कार्यालय की तरफ कूच करेंगे। राजा ने आरोप लगाया कि मोदी ने 2012 में किए गए इस सौदे में बदलाव किया है और इन विमानों की खरीद पहले की तुलना में कहीं अधिक कीमत पर की जा रही है। उन्होंने यह भी आरोप लगाया कि मोदी ने विदेशी सहयोग से देश में इन विमानों को बनाने का काम सरकारी क्षेत्र की कंपनी एचएएल के बजाय एक निजी कंपनी को दे दिया है।
